### Position Summary

This internship is based in Austin (remote with possibility of hybrid work) and provides general support to the CDF-TX Immigration team. The intern works between 10 to 20 hours/week and provides substantive research, compiles reports, monitors legislative committees, and helps with the execution of advocacy-related activities, including story collection, public education, legislator visits, legislative briefings, special event planning, and social media work.

- Compile bi-monthly immigration newsletters
- Assist in the development and execution of special projects, such as the SeguroTexas campaign
- Perform other division, department, and organization-wide special projects as needed
